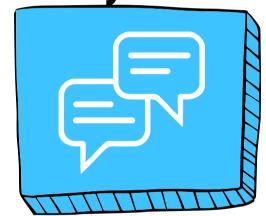
How it WORKS?

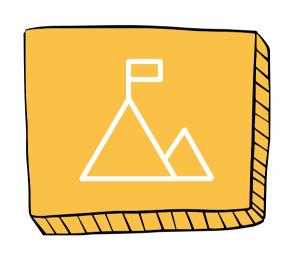


05. University Issues I-20

03. Student Applies for Verification

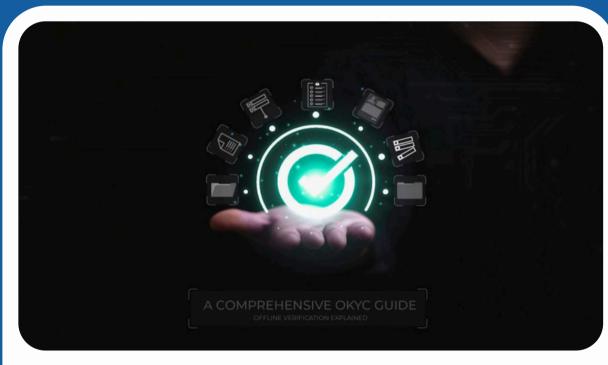
The student submits documents to YVS for comprehensive verification.
